Our Child Protection Policy focuses on four key action areas: awareness, prevention, reporting and responding. We place special emphasis on awareness and prevention to safeguard children. In case of a reported child safeguarding concern, it is taken seriously and addressed without delay.

The purpose of this policy;

To protect children and young people who attend Talents Theatre School.

To provide staff and volunteers of Talents Theatre School with our guide to safeguarding and child protection.

Our Child Protection Policy and Procedures

Talents Theatre School recognise that:

- The welfare of the child is paramount, as stated in the Childs Act 1989
 all children regardless of age, disability, gender reassignment, race, religion or belief, sex or sexual orientation.
- Some children are additionally vulnerable because of the impact of previous experiences, their level of dependency, communication needs or other issues.
- Working in partnership with children, young people, parents and carers is essential in promoting young peoples welfare

We will seek to keep children and young people safe by:

Valuing them, listening to and respecting them

Appointing a Designated Safeguarding Officer for children and young peoples safeguarding.

Adopting child protection and safeguarding practices through procedures and a code of

good conduct for staff and volunteers.

• Developing and implementing an effective safety policy and related procedures.

• Recruiting Staff and Volunteers safely, ensuring all necessary checks are made.

Recording and storing information professionally and securely.

Creating and maintaining an anti-bullying environment, and ensuring any incident are dealt

with in an effective manner.

Ensuring that we provide a safe environment for our children and young people.

Online Safety

• It is essential that children are safeguarded from potentially harmful online material and

inappropriate conduct or contact.

• We strongly advise mobile phones & devices are left at home and not used while at our studio.

• Staff behaviour should refer to the acceptable use of technologies.

• Staff should contact a parent /guardian rather than a young student.

• All contact should be professional and not breach any prevention of abuse guidance in this

document.

• All information regarding young people is subject to GDPR and the Data Protection Act 2018.
